**Membership dues are \$80.00 for the first year and \$60.00 (\$40.00 with work credit) for each subsequent annual renewal.** The membership year runs from April 1<sup>st</sup> until March 31<sup>st</sup>. New members who join after December 1<sup>st</sup>. will be extended through the next membership year. Please note that club members are responsible and must be present with family members and guests they bring to the range.

As a member of the Tri-Cities Metallic Silhouette Association (TCMSA), each person is expected to contribute their fair share of the time and effort needed to make our organization functional and strong. Each year the club schedules several "*work parties*" and it is expected that each member attend at least one work party or make arrangements (to provide alternative services in lieu of work party participation) with the club officers. Members that participate in a work party or suitable alternation will receive a **\$20.00 reduction** in membership fee for the next annual membership renewal.

**National Rifle Association (NRA) membership is also a requirement for TCMSA membership.** If you are not a member, the club secretary or other club officer will be glad to assist you in applying for you NRA membership. **NO MEMBER WILL BE ISSUED ACCESS TO THE RANGE WITHOUT A VALID NRA CARD OR RECEIPT FOR NRA MEMBERSHIP.**

The club publishes an informal newsletter to keep it's membership informed of the date and place of the club meetings, the agenda, planned dates for Hunter Safety, matches, match results, work party dates, member classified ads, and other information of potential interest to members.

6. I acknowledge the proper means of enforcing the club's safety rules is to tactfully point out the situation to the individual performing the act in question. I understand that if this does not correct the situation, I am to:
  - a) Obtain the individual's name and/or automobile license plate number,
  - b) Leave the range, and
  - c) Report the situation to a club officer and/or to the membership at a regularly scheduled club meeting.
7. I acknowledge failure to comply with the club's safety rules by myself or by any of my guests can result in my immediate removal from the range and/or permanent removal from the club.
  - a) I agree that if I am asked to leave the range for safety reasons, I will peacefully leave the range.
  - b) I understand I can originate a discussion of the situation at the next regularly scheduled TCMSA meeting;
  - c) I will not create a confrontation at the range.
